FIRST CALL – NOTES FROM THE FRONT

YADA, YADA, YADA ...

If I remember the Seinfeld episode correctly, “Yada, Yada, Yada ...” was used when Elaine or Jerry or George wanted to recount a conversation or an idea, the details of which really weren’t worth discussing, or when they wanted to quote someone who, or something that really wasn’t interesting. Thus, “Yada, Yada, Yada ...”.

Late last month I attended a function, ostensibly to honor women veterans. Women veterans deserved to be honored. In the wars in my adult lifetime many have been killed (VN – 8, Desert Storm – 15, OEF – 13, OIF – 96.) That’s what made me drive several hours to attend the luncheon – they had more than earned it.

Unfortunately, I experienced “Yada, Yada, Yada...” once again, and to the extreme. The speakers were variously a congressperson, a state official, and a local officeholder. It was absolutely *déjà vu* – Seinfeld revisited. As far as the speakers were concerned what they were mouthing were just words, conveniently interspersed with the word “veteran” at an interval undoubtedly calculated by some PR specialist on their staff to be most effective – and mind-numbing.

Some of the sentences didn’t even parse. Most of the comments were little more than a jumble. The basic thought was, “Aren’t I a wonderful important person.” The message was, “You are great, but let me tell you why I am the real hero for doing all this great stuff for you.” “Just check my website or call my office and I’ll tell you even more about what a brave person I am on this (and other) issue(s).” And, “There are jillions of benefits available for you – check my website.” And “If you have any personal problems – well Yada, Yada, Yada ...”

Not one word about the real sacrifice these young women and their predecessors have made except in the most general terms. Not one mention of the deaths and woundings. Not one mention of the destroyed relationships and marriages. Not one mention of the widowers and children that some have left behind. Not one mention of the employers who were denying them reemployment or the shameful performance of the bureaucracies that were denying them benefits.

Most especially, not a single word except praise for all of the benefit-givers. The state official waxed poetic about the joys and beauties of our state’s oldest veterans’ home. It apparently has no problems, neither do the other two in the state – [check this](#). Neither does any other veterans’ facility or office. That’s amazing considering that across the board these hospitals – both military and VA – are being found wanting in seriously gross terms.

The word “veteran” is one of those wonderful political catchwords that has come to serve many purposes – almost none of them related to providing real services to real veterans.

Adding “veteran” to a bill almost surely will get it into the newspaper, even if it never gets enacted. Citing how many bills they have authored or cosponsored for “veterans” makes great political speech fodder for politicians. We have even found in the recent class action lawsuit that the fact that you are established to aid veterans – as in the Department of Veterans Affairs – means that you should be free from criticism, and most especially free from oversight by either Congress of the courts – only praise is permitted, and only praise is patriotic. Of course they don’t have to worry too much about oversight from the Congress anyway – that is no longer in the job description.

A *Thomas* search turns up 435 bills with “veteran” in their title or text for the current session of Congress. Does anyone believe that more than a handful of those will be passed? Does anyone believe that the bills that are passed will address the real problems of veterans? Does anyone doubt that all 435 will be cited in some political speech sometime soon as evidence of a Congressperson’s undying support for “veterans”?

In my home state of California during the last legislative session, veterans bills were routinely passed in committee and then rewritten to serve other purposes completely before they were sent for a floor vote – a wonderful process called “gut and amend”. This lets the original author claim credit for writing a bill in favor of veterans; lets the veterans’ committee take credit for passing it out of committee to the floor of the legislature, and then lets some power broker rewrite it to serve some business purpose that is not even remotely connected to veterans – same bill number; same approvals; different title, purpose, and author. Everyone (except veterans) is happy; everyone (except veterans) gets paid; no one (except veterans) gets screwed.

So remember. Our leaders have given us the example. Whenever you are forced to contemplate the abominable treatment that veterans are getting today, just “Yada, Yada, Yada...”. Whenever you have to pony up to help veterans, just “Yada, Yada, Yada...”.

The only time that this will be a problem is when you have to look into a veteran’s eyes.

“Yada, Yada, Yada...” just doesn’t cut it then, does it?

VA CHIEF DENIES COVER-UP OF SUICIDE DATA

WASHINGTON - Veterans Affairs Secretary James Peake says data about the number of veterans attempting suicide were not released because of concerns about its accuracy.

E-mails among VA officials were recently disclosed during a trial in San Francisco that suggested some might have been attempting to hide the number of attempted suicides by those under the agency's care. The judge has not yet ruled in the lawsuit filed by two veterans groups. MAIL CALL - LETTERS FROM MEMBERS AND OTHERS

A TELLING LETTER TO OUR PARTNER IN THE CLASS ACTION LAWSUIT, DISABILITY RIGHTS ADVOCATES *(edited for length)*

I am the mother of a 32-year-old, disabled veteran whose battle with schizophrenia (service-connected, 70% rating) has caused two suicide attempts, the last in 2006 resulting in my resignation from public employment to provide full-time daily preventive care management, behavioral intervention, medication monitoring and maintenance, social engagement, along with a structured and least intensive living environment.

On behalf of my son and the thousands of other veterans [for whom]you are seeking justice, I am honored to be able to thank you for your pro-active legal response to the willful mistreatment of mentally and physically ill veterans, the willful distortion of facts and law, and the devastating destruction of military families through the deliberate prolonged processing of compensation claims, all at the hands of the Department of Veterans Affairs (hereinafter referred to as "DVA").

My son's battle with the DVA has been the same as thousands of other veterans, an adversarial process geared toward defeating and further injuring the physically and mentally ill. I have been fortunate, however, that my training as a paralegal and 20+-year legal background has enabled me to research and analyze the rating criteria/law and the medical rating criteria found in the DSM-IV-TR on behalf of my son. Please be advised, however, that oftentimes my son was ambushed by rating decisions that ignored doctor recommendations, "partial" excerpts extracted from medical records and law that were advantageous to the DVA, the deliberate ignoring of entire passages advantageous to the veteran, along with issuance of downright lies in rating decisions.

After filing numerous pleadings/appeals ranging in page length from 16-65 pages each, my son and I were given an ultimatum to accept a 70% rating decision with the stipulation that we would not pursue any further appeals. Given the demands of my son's condition, the average length of appeals, and being worn from the lethal blows from the DVA, we accepted the rating decision. Accordingly, the 65-page Appeal Brief exhibiting a thorough analysis of Title 38 CFR §4 and the DSM-IV-TR was purged from DVA records and returned to me in order for my son's case to go "by, by" as communicated by the representative from the Disabled American Veterans. The DVA preys on veterans unknowledgeable of the law; thus, they can narrowly interpret and misinterpret to the DVA's advantage. Of course, the DVA passionately wanted to get rid of my intervention on my son's behalf.

MAJOR BREAKTHROUGH - REDUCING THE STIGMA OF MENTAL HEALTH ISSUES

CSA SENDS – *(Chief of Staff of the Army) (edited for length):*

... The Army requested and the Secretary of Defense won approval for revision of Question 21 on the National Security Positions Questionnaire (Standard Form 86). The revision now excludes counseling for adjustments from service in a military combat environment, as well as counseling related to marital, family and grief issues. ...

This is good news. Hopefully this decision will serve to lessen Soldier and Army Civilian concerns that psychological or behavioral health counseling may jeopardize their security clearance or adversely impact their career.

This change will allow for issues to be identified and addressed earlier - before psychological stress escalates to a more serious condition that may further impact the individual, units, Families and our overall readiness.

AKAKA INTRODUCES BILL TO CONTINUE OVERSIGHT FOR TROOPS RETURNING FROM COMBAT INTO NEXT ADMINISTRATION

Bill calls for three-year extension for VA/DoD Senior Oversight Committee

WASHINGTON, D.C. - U.S. Senator Daniel K. Akaka (D-HI), Chairman of the Veterans' Affairs Committee, introduced a bill yesterday to ensure the continuation of the VA/DOD Senior Oversight Committee (SOC), the entity responsible for improving transition from military service to veteran status for severely wounded and injured servicemembers. The SOC was formed in the wake of last year's Walter Reed scandal and is scheduled to be terminated in January 2009.

"The conflicts in Iraq and Afghanistan will outlast the current Administration. So too should the Defense and Veterans Affairs Departments combined efforts to assist servicemembers returning from war," said Akaka. "I am committed to sustaining this effort as long as our troops are in combat."

THOMPSON AND REHBERG FIGHT FOR VETERANS UNKNOWINGLY EXPOSED TO TOXIC TESTS IN 60S AND 70S

WASHINGTON – Today, Congressmen Mike Thompson (D-CA) and Denny Rehberg (R-MT) introduced legislation that would provide healthcare to veterans who were unknowingly subjected to biological and chemical weapons tests conducted in the 1960s and 70s.

The existence of these tests, known as Project 112, including Project SHAD, was denied by the Department of Defense (DoD), despite reports from participating veterans that they were being stricken with unusual diseases. The DoD now acknowledges that the tests took place, but the Veterans Administration (VA) will not provide these veterans with health benefits and compensation for their diseases. The Thompson-Rehberg legislation would require the VA to assume the toxins used in the weapons tests caused injury to the veterans, making them eligible for medical benefits and/or compensation for their conditions.

"For ten years, I've been fighting to get the government to acknowledge that these extremely dangerous tests made some of our brave veterans sick and even caused some of their deaths," said Thompson. "These men risked their lives for their country, and in return, their government treated them like guinea pigs and has for years turned its back on them. This legislation will make sure they don't have to wait any longer for the help they need and deserve."

SENATE SEEKS ADDITIONAL BOOST TO MILITARY PAY

WASHINGTON -- Senate lawmakers on Thursday backed a higher-than-requested 3.9 percent pay raise for all military personnel in their first draft of the fiscal 2009 defense authorization bill. Lawmakers said the 3.9 percent pay raise, 0.5 percent above what defense officials requested, is designed to further close the gap between military and civilian pay. POSSIBLE VETS' BENEFITS UPGRADES

The veterans' committee approved a bipartisan GI Bill improvement package amended, at Buyer's urging, to include provisions that would boost education benefits for National Guard and reserve members mobilized in support of contingency operations.

The bill, HR 5684, would raise active-duty GI Bill benefits to \$1,450 a month, up from the current \$1,101 payment; pay a \$500 monthly stipend for living expenses; give people up to 15 years after leaving active duty to use their benefits, rather than the current 10; and allow up to \$6,000 in GI Bill benefits to be used each year to repay student loans. Buyer's amendment would

modify a current program for active-duty troops, making GI Bill benefits available to reservists based on cumulative rather than consecutive service, and make benefits more generous.

There was no controversy over the amendment, which was adopted by voice vote, but adding reserve benefits to the measure requires the bill to be referred to the House Armed Services Committee, which has jurisdiction over Guard and reserve education benefits. <More at: www.armytimes.com/news/2008/04/military_veteransbills_delays_043008w/>

PENTAGON CONSIDERS ADDING FORCES IN AFGHANISTAN

WASHINGTON — The Pentagon is considering sending as many as 7,000 more American troops to Afghanistan next year to make up for a shortfall in contributions from NATO allies, senior Bush administration officials said. They said the step would push the number of American forces there to roughly 40,000, the highest level since the war began more than six years ago, and would require at least a modest reduction in troops from Iraq.

The planning began in recent weeks, reflecting a growing resignation to the fact that NATO is unable or unwilling to contribute more troops despite public pledges of an intensified effort in Afghanistan from the presidents and prime ministers who attended an alliance summit meeting in Bucharest, Romania, last month. <More at: www.nytimes.com/2008/05/03/world/asia/03military.html>

U.S. SEEKS CONTRACTORS TO TRAIN IRAQI MILITARY

U.S. commanders in Iraq are for the first time seeking private contractors to form part of the small military teams that train and live with Iraqi military units across the country, according to a notice for prospective bidders published last week. The solicitation, issued by the Joint Contracting Command in Baghdad, says the individuals that a contractor recruits -- who would include former members of the U.S. Special Forces and ex-Iraqi army officers -- will be trained in the United States with military transition teams (MiTTs) and shipped as a single team to Iraq. The recruits will live on Iraqi military bases "under Iraqi living conditions and participate with MiTT special operations and convoy duties," the solicitation says.

MARINES LIVING OUT THE MOTTO: 'FIRST, DO NO HARM'

One by one, young Marines in full battle gear climbed into the turret of a desert Humvee parked on a live-fire range at Fort Pickett. The troops had almost no combat experience -- one in 10 has deployed. An instructor told them to imagine a vehicle was approaching their checkpoint. The Marines had to decide when to reach for a warning flare and when to snap off rounds from their automatic rifles.

DOD OFFICIAL DEFENDS FELONY WAIVERS

About 20 percent of all recruits in the U.S. military enter the service with either a medical or conduct waiver, a senior Pentagon official said today. Last year the services recruited more than 181,000 new members, more than 36,000 of whom came in on some sort of waiver. About one third of the new recruits were admitted with medical problems and the remainder were waived in despite past criminal activities -- including misdemeanors and some felonies, said Bill Carr, the Pentagon's deputy undersecretary for military personnel policy. <More at: www.military.com/news/article/dod-official-defends-felony-waivers.html>

DESPITE ALERT, FLAWED WIRING STILL KILLS G.I.'S

WASHINGTON — In October 2004, the United States Army issued an urgent bulletin to commanders across Iraq, warning them of a deadly new threat to American soldiers. Because of flawed electrical work by contractors, the bulletin stated, soldiers at American bases in Iraq had received severe electrical shocks, and some had even been electrocuted. The bulletin, with the headline "The Unexpected Killer," was issued after the horrific deaths of two soldiers who were caught in water — one in a shower, the other in a swimming pool — that was suddenly electrified after poorly grounded wiring short-circuited.

... American electricians who worked for KBR, the Houston-based defense contractor that is responsible for maintaining American bases in Iraq and Afghanistan, said they repeatedly warned company managers and military officials about unsafe electrical work, which was often performed by poorly trained Iraqis and Afghans paid just a few dollars a day.

One electrician warned his KBR bosses in his 2005 letter of resignation that unsafe electrical work was "a disaster waiting to happen." Another said he witnessed an American soldier in Afghanistan receiving a potentially lethal shock. A third provided e-mail messages and other documents showing that he had complained to KBR and the government that logs were created to make it appear that nonexistent electrical safety systems were properly functioning.

ARMY WIDENS PROBE AFTER FINDING BAD CONDITIONS AT FORT BRAGG

Army officials said Tuesday they are inspecting every barracks building worldwide to see whether plumbing and other problems revealed at Fort Bragg, N.C., last week are widespread. Brig. Gen. Dennis Rogers, who is responsible for maintaining barracks throughout the Army, told reporters at the Pentagon that most inspections were done last weekend but he had not seen final results. While not providing specifics about problems discovered during the weekend inspections, Rogers indicated some deficiencies were corrected. In cases where extensive repairs are deemed necessary, the soldiers in that housing would be moved elsewhere until the fixes are completed, he added.

Rogers said it was too soon to know whether the Fort Bragg problem was an isolated incident. He acknowledged the revelations from a video shot by the father of an 82nd Airborne Division soldier showing poor conditions such as mold inside the barracks, peeling interior paint and a bathroom drain plugged with sewage.

The soldier's father, Ed Frawley, said he was disgusted by the conditions that greeted his son and the rest of his 82nd Airborne unit that returned on April 7-8 after a 15-month tour of duty in Afghanistan.

AMERICA'S CHEMICALLY MODIFIED 21ST CENTURY SOLDIERS

Armed with potent drugs and new technology, a dangerous breed of soldiers are being trained to fight America's future wars.

Amphetamines and the military first met somewhere in the fog of WWII, when axis and allied forces alike were issued speed tablets to head off fatigue on the battlefield. More than 60 years later, the U.S. Air Force still doles out dextro-amphetamine to pilots whose duties do not afford them the luxury of sleep.

WEST POINT GRAD TO SERVE - ON GRIDIRON

Caleb Campbell will graduate from the U.S. Military Academy on May 31. He will be an officer in the Army on active duty.

If not for a new policy allowing him to play pro football, he would be an air defense artilleryman, a platoon leader in charge of about 32 soldiers, likely headed to Iraq or Kuwait.

Instead, he'll be suiting up to play for the Detroit Lions.

"I find it really as a win-win situation," Campbell said Tuesday in a national media conference call. "I get to pursue a career because of this new policy the Army has implemented, doing something that I love, and that's playing football.

AND WHAT DID THIS COST YOU AND ME?

The four years of experience at the United States Military Academy at West Point are estimated to be worth \$478,000. Producing leaders for the US Army is a very expensive process. Is the investment worth it? Yes, because these future officers protect all American citizens from endangerment and chaos. Also keep in mind that this annual figure of about \$120,000 includes everything tuition; room & board; military training; intramural activities; travel; accumulated pay of about \$10,000 per year; medical and dental care; uniforms; clothing; books; computers; laundry and haircuts. COMMITTEE CHAIRMAN ACCUSES VA OF CRIMINAL NEGLIGENCE

WASHINGTON (AP) -- The Department of Veterans Affairs' top mental health official said Tuesday he made a poor choice of words when he sent his colleagues an e-mail about suicide data that started out with "Shh!" Dr. Ira Katz, the VA's mental health director, told the House Veterans Affairs Committee that the e-mail was in poor tone -- even though the body contained "appropriate, healthy dialogue" about the data.

"I deeply regret the subject line," Katz said. "It was an error and I apologize for that."

... The committee's chairman, Rep. Bob Filner, D-Calif., accused Katz of being more concerned about how data was interpreted than the health of veterans. He also said Katz -- as well as others involved -- should be fired. POST-WAR SUICIDES MAY EXCEED COMBAT DEATHS, U.S. SAYS

The number of suicides among veterans of wars in Iraq and Afghanistan may exceed the combat death toll because of inadequate mental health care, the U.S. government's top psychiatric researcher said. Community mental health centers, hobbled by financial limits, haven't provided enough scientifically sound care, especially in rural areas, said Thomas Insel, director of the National Institute of Mental Health in Bethesda, Maryland. He briefed reporters today at the American Psychiatric Association's annual meeting in Washington.

Insel echoed a Rand Corporation study published last month that found about 20 percent of returning U.S. soldiers have post-traumatic stress disorder or depression, and only half of them receive treatment.

The last time Susan Nichols brought her husband home from Brooke Army Medical Center in San Antonio, she knew something was very wrong. He couldn't even play with their 6-year-old son and 5-year-old daughter. Instead, he just watched them play basketball with the neighborhood kids.

"He was constantly dizzy, or he just couldn't handle being out because of the pain, or the medication just knocked him out completely and he couldn't even walk," Nichols recalled while sitting on the patio at her home in San Antonio. "And the last day that we all saw him, he could barely stand up straight without leaning against a wall to prop him up."

Two days later, on Jan. 22, Sgt. Robert Nichols was found dead in his room at Brooke Army Medical Center. The autopsy report said he died of an accidental drug intoxication from the pills he had been prescribed by his Army doctors. Problems Present Long, Hidden Toll; Help Often Avoided

WASHINGTON -- The wars in Iraq and Afghanistan have caused heightened stress, depression and sleeplessness among some military personnel and their families, a new report says. The [survey](#) by the American Psychiatric Association, set to be released Wednesday, found that 32% of military members believe their tours in the two war zones had "at least some negative impact" on their mental well-being. Among military spouses, 40% believed their mental health was hurt by their husband's or wife's service overseas. Many members of the military community remain reluctant to request counseling, the report found. Almost 75% of the military personnel felt that seeking help would harm their careers, while 66% of the military spouses worried that looking for assistance for their own issues would harm their loved ones' chances of promotion.

NATIONAL GUARD AND RESERVE MOBILIZED AS OF MAY 7, 2008

This week the Air Force announced an increase, while the Army and the Marine Corps announced a decrease. The Navy and Coast Guard numbers remained the same. The net collective result is 541 fewer reservists mobilized than last week. At any given time, services may mobilize some units and individuals while demobilizing others, making it possible for these figures to either increase or decrease. The total number currently on active duty in support of the partial mobilization of the Army National Guard and Army Reserve is 78,085; Navy Reserve, 5,014; Air National Guard and Air Force Reserve, 8,503; Marine Corps Reserve, 8,522; and the Coast Guard Reserve, 347.
